The Test

- Past oriented
- Stars
 - Teen mother
 - Pregnancy test
 - As many as 10 tests taken
 - "Because the come in a box of 10"
 - "Just to be sure"
- Reality of pregnancy
 - Concrete

Loss of My Body

- Focus on present
- Stars
 - Teen mother
 - Her physical body

The Loss of My Body

■ Body is focus of tangible change

"I don't know, I didn't think that I would gain as much weight as I have. Cuz, I try and put on my old clothes but, it's depressing that I can't fit into them anymore. My legs are like thunder thighs, I can't pull up my pants any higher than my knees anymore. My old pants, I only have three pairs of pants now, and I used to have like over 25 pairs of pants."



In My Arms

- □ Focus moves into the future
- Stars
 - Teen mother
 - Baby
 - Imagined and dreamed of child

In My Arms

- Hopes and dreams future
 - Child
 - "energetic, happy, jumping around everywhere, playful, always wanting to do something."
 - "I hope she is more like me than her dad. I hope she has all of both our good qualities."

In My Arms

Hopes and dreams of future

- Mothers
 - "How I want it to be is, like, with me and Jacob having our own apartment and just like, you know, waking up and like taking care of her and going and doing things and stuff and Jacob going to school and everything and then coming home and like making dinner and like, you know, just the typical family stuff."
 - "So after I turn 18 and probably after the baby is born, I am going to get my GED and get into college classes."

Implications to Nursing

- Disconnect from traditional/expected motherhood narrative
 - Baby is focus
 - Do what is "good for the baby"
 - Mother is vessel
 - Purpose is to sacrifice for child

Implications to Nursing

- Unique position to aid in construction of mother identity
 - Care and education
 - Prenatal, labor and delivery, postnatal
 - Resist negative images and myths
 - Do not represent experiences of teens
 - Anticipatory guidance
 - Support systems
 - Development

Future Research

- Grand narrative comparisons
 - Mass media
 - Teens
 - Parenting
 - Pregnant and not parenting
 - Non-parenting
- Longitudinal Study
 - Teen mother identity development
 - Focus groups
