Family Influences Health

- Families have powerful influence on health, equal to traditional medical risk factors
- Critical and hostile family relationships have negative influence on health
- Supportive family relationships improve outcomes

- Family emotional closeness

- Caregiver skills
- Clear family coordination
- Direct communication



Risk Factors

- Isolation
- Stressors
- Family rigidity
- Family Conflict

Nursing Practice Focused on Family



- Improves family coping
- Impact on individual patient and family outcomes
- Quality of care
- Provides support
- Softens suffering

- Family coping

- Nurses report a lack of confidence and competence in working with families
- Focus on the individual and technical skills




