Background

- Scarce research funding
 - 11% of new applicants are funded at NINR
 - < 20% are funded overall at NIH
- Tedious application funding processes
 - Time-intensive
 - Difficult
 - Particularly at non-research intensive institutions
- Research expectations for tenure



Problem

The scarcity of funding sources compels nurse researchers to seek funding from novel sources

- New Access to funding sources
 - Widely available due to social media
- Common websites
 - Go Fund Me
 - Kickstarter
 - Donors Choose
 - Fundable
 - Experiement.com



Our Experience

- Experiment.com
 - Initial competition
 - · Small, private liberal arts undergraduate institutions
 - Viability
 - Second pilot
 - 10 universities
 - One of 4 teams
 - Across disciplines
 - Learning curve and caveats



Barriers

- Requirements
 - Detailed familiarity
 - Technology
 - Multiple social media platforms
- Extensive amounts of time
 - Presence on multiple social media platforms
 - Donor unfamiliarity with mechanisms
 - Lack of trust
 - Responses to negative comments



Barriers cont'd

- Personality in relation to this experience
- Public competition with colleagues
 - Successful vs unsuccessful funding



Benefits

- Application process
 - Assistance provided
- Publicity
- Feelings of success
- Possibilities of being overfunded
- Useful, alternative for funding
 - Students
 - Postdoctoral scholars
 - Faculty
 - Staff



Conclusion

- Crowdfunding platforms are innovative, alternate sources of revenue for nursing research.
- Great potential for successful funding
 - Public awareness
 - Contributions to research topics
- Awareness of benefits and barriers aids in preparation.
