Background

- **Increased investments in Health**
- **Inadequate translation of investments into good health outcomes**
- **Need for renewed efforts to strengthen health systems**
- **New Public Health Challenges**

Systems Challenges in AFRO

- Inadequacies in the health workforce.
- Low levels of government spending coupled with high out of pocket payments.
- Weak procurement and supply systems.
- Poor information and monitoring systems.
- Weak community engagement.
- Africa's unique health landscape along with a looming NCD catastrophe coupled with vibrant social-demographic and economic growth.

Some Challenges in the AFRO cont'd

- **Demographic Transition**-Youth & elderly increases
- **Epidemiologic Transition** - CD & NCD double burden
- **Economic Transitions** – newly middle income countries; middle class; urbanization, demand shifts
- **Political transitions** – None peaceful power transitions*
- **Social and cultural transitions**- modernity with traditions that affect health
- **Climate & Environmental Risks**- frequent outbreaks, disasters, conflict
- **Varying Country context in Africa** (LIC, LMIC, HICs and HIC with Low Health Indicators)

An overview of WHO in AFRO

- **WHO** is the directing and coordinating authority on international health within the United Nations' system
- In the African region and elsewhere, it does by:
- **providing leadership** on matters critical to health and engaging in partnerships where joint action is needed;
- shaping the **research agenda** and stimulating the generation, translation and dissemination of valuable knowledge;
- setting **norms and standards** and promoting and monitoring their implementation;
- articulating **ethical and evidence-based** policy options;
- providing **technical support**, catalyzing change, and building sustainable institutional capacity; and
- **monitoring** the health situation and assessing health trends

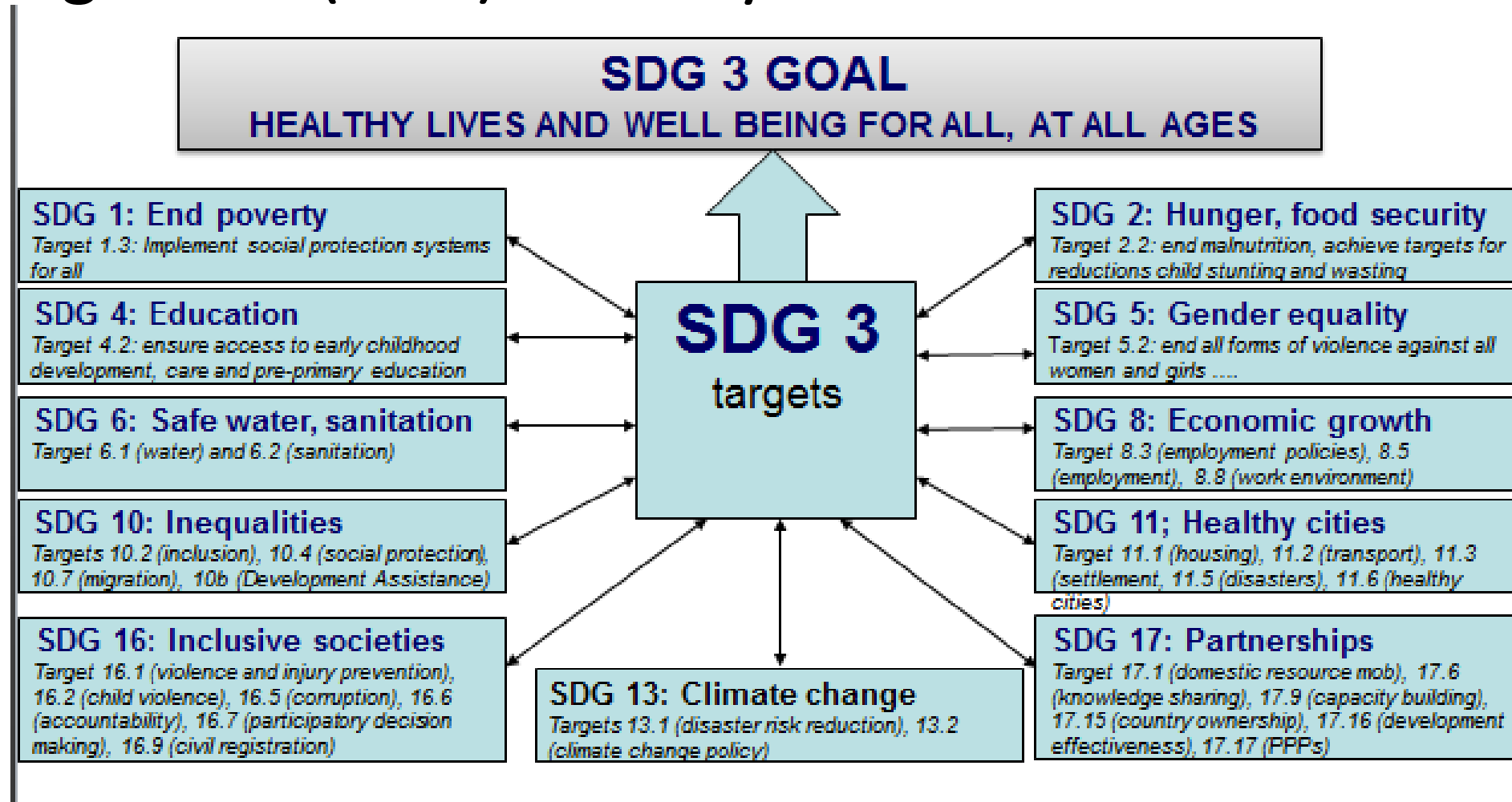

Achieving the SDGs and UHC: Lessons from the MDGs

- **We need to make good policies and strategic choices to achieve UHC.**
- **SDGs will not be achieved without effective country leadership, stewardship and country ownership of the goals.**
- **Relevant stakeholders must be mobilized and effective partnerships built to guide domestic and external investments towards the goals.**
- **Partnerships must go beyond traditional partners to include intersectoral collaboration with non-traditional partners**

Some Proposed Africa Region Targets

By 2030,

at least 80% of Member States will have health systems that are performing optimally* for effective delivery of essential package of health and related services

By 2030,

all Member States will have at least 80% of their populations utilising the identified essential package of health and related services

By 2030,

all Member States will have in place and be implementing the investments plans needed to align their health systems to the SDGs

Proposed Milestones for the African Region

By
2021

50% of all Member States will show evidence of improving population coverage of agreed standards and assessments.

50% of Member States will have evidence of improving health system performance as measured by the framework

80% of Member States will have started implementing the health system investments plans required for optimal performance

By
2025

80% of Member States will show evidence of improving population coverage of agreed standards and assessments

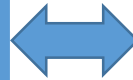

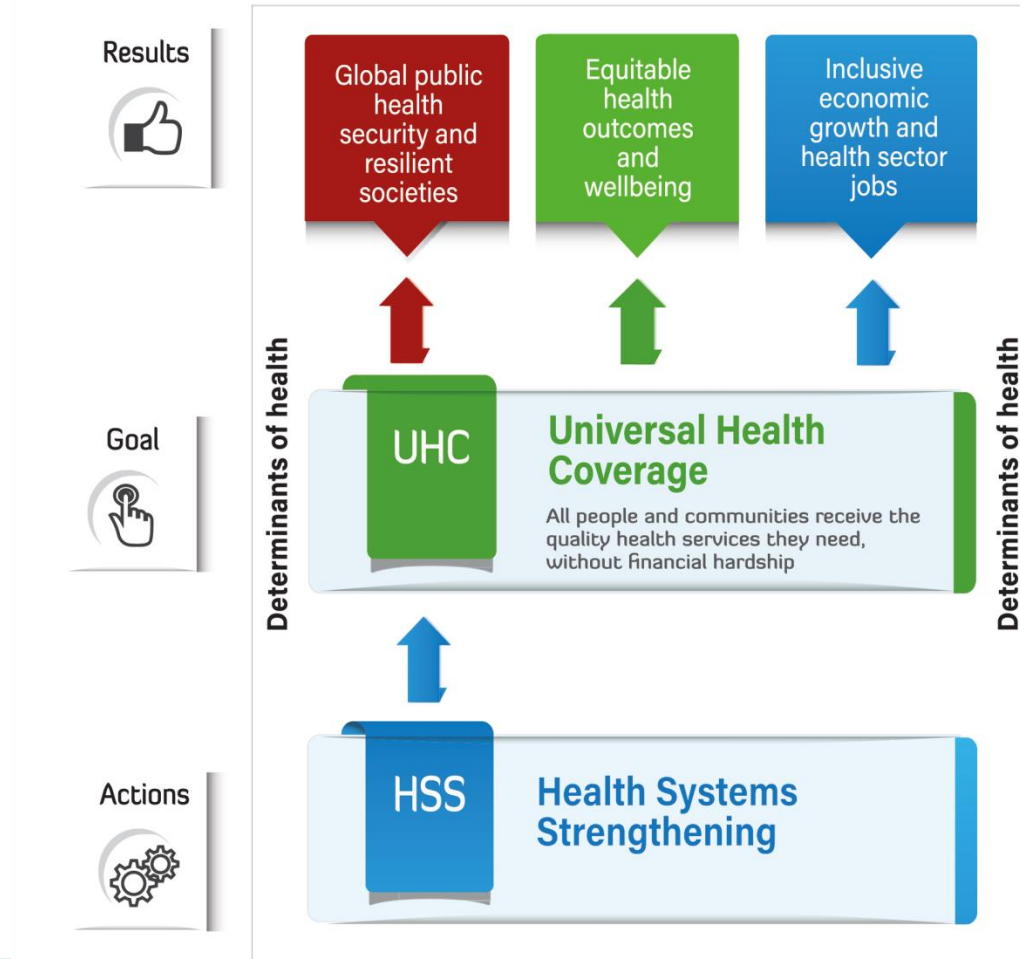
